Last month the following article appeared in one of the newspapers:-The minister of minerals and resources, said she is concerned at the gaps in the safety standards in the mining industry.

A mine safety audit report detailing the high number of injuries and fatalities in South Africa's mines each year has been released by the department. It shows that in the past three years, unsafe working conditions have led to the death of 200 mine workers annually, in addition to the almost 5 000 people who are injured.

Many of these injuries are so severe that limbs need to be amputated which leads to a significant reduction in standards of living and ability to earn an income.

"If one looks at the statistics, they do not paint a particularly rosy picture of the state of affairs in this important sector of our economy," said the minister, reacting to the report, which was released by the department at the request of the Presidency in Pretoria on Monday.
