"At the last Board meeting, the aspect of Cyber Security was on the agenda of the meeting because an item in the external auditor's report criticized the lack of Cyber Security accountability and responsibility on Board level.

Please provide me with a comprehensive memorandum on this matter indicating for eg

- Why the Board has this accountability and responsibility as the Board presently views this as a technical matter.
- Motivate your view in terms of international guidance on this matter
- If possible, give a specific example of where a Board was confronted with this aspect
- A detailed plan of how we can convey this message to the Board in our company

Please send me a comprehensive memorandum on your views about the items noted above which I can include in the Board agenda."

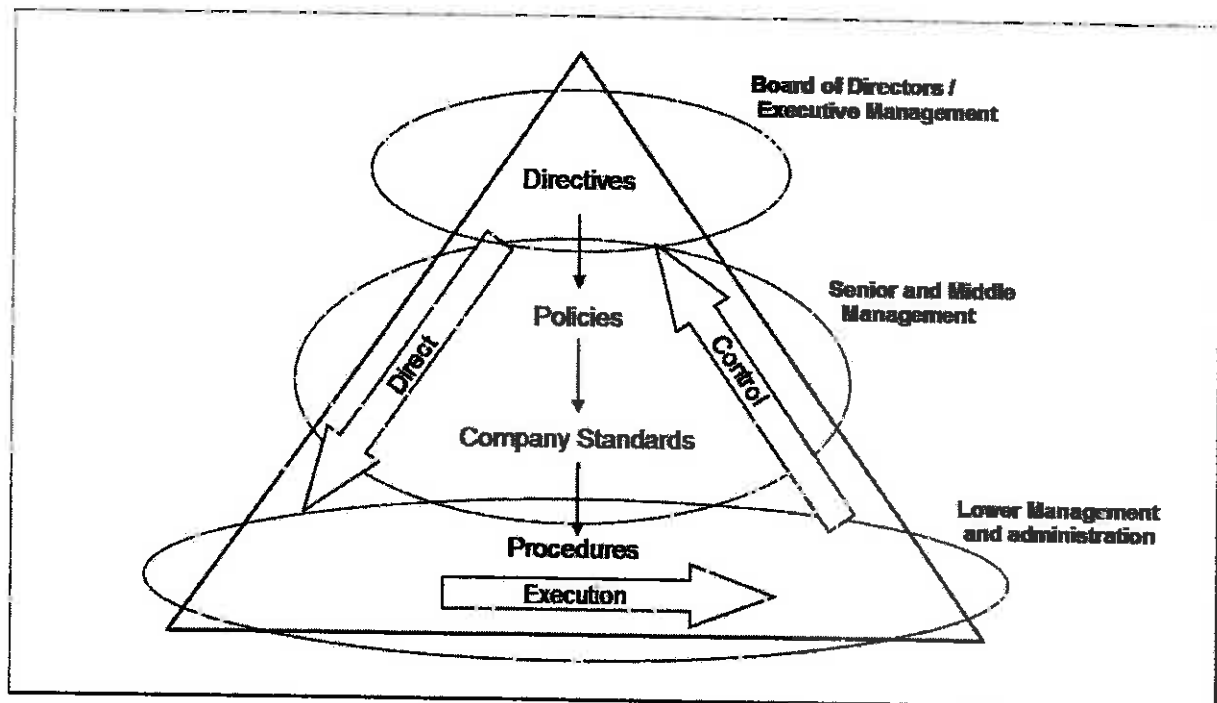
