Write an essay of about 3-4 pages in which you:

- Reasons for the emergence of the approach
- Critique of the approach
- Implications of the Newfield and Maungedzo study

QUESTION 3: LANGUAGE POLICY AND PLANNING

James Tollefson has argued that "while vast resources are directed toward language teaching and bilingualism, especially involving English, more people than ever are unable to acquire the language skills they need in order to enter and succeed in school, obtain satisfactory employment, and participate politically and socially in the life of their communities. ... The great linguistic paradox of our time is that societies which dedicate enormous resources to language teaching and learning have been unable – or unwilling to remove the powerful linguistic barriers to full participation in the major institutions of modern society. (Tollefson 1991:7)

In an essay of between 3 and 4 pages discuss this statement by Tollefson in relation to the language policy and planning situation of South Africa.
