Question 1: Essay (Ethical and Legal)

In what is believed to be an attempt to suppress the leak of 17GB of sensitive emails belonging to the Minister of Energy and Natural Resources, the Turkish government reportedly put measures in place to block a range of cloud storage services (that include Google Drive, Dropbox, Github, and OneDrive) in October 2016. Censorship monitoring groups allege that the move is an attempt to prevent people from hosting the e-mail dumps and thus making it more widely available.

In the form of an essay, discuss both the ethical and legal aspects relating to the above case study. Structure your essay carefully so that it presents a logical discussion that covers the following themes:

- a) For each of the three Eurocentric ethical theories covered during the (18) module:
 - ◆ Name the ethical theory (1)
 - ◆ Discuss what the ethical theory espouses (2)
 - ◆ What would an individual who strictly follows such an ethical theory do with regards to the censorship? Motivate your answer (3)
- b) How is the Internet regulated? With reference to the above case study, discuss the challenges (or ease) with which the different components of the Internet may be regulated (2 x 9 marks each)

A final four (4) marks are allocated to having answered the essay's overall question in the introduction and/or conclusion.

Do you agree with Judge Orrick's ruling? Motivate your answer by:
 - ◆ Explaining what copyright is (2)
 - ◆ Listing the requirements for copyright to be held (4)
 - ◆ Indicating whether the requirements hold or not (2)
- c) In January 2016, the Johannesburg High Court ruled in favour of Gareth (10) Cliff in his Idols contract dispute with M-Net. Explain the rationale of the ruling first by discussing the legal requirements of contracts and relate how it applied to the Cliff/M-Net case study.
- d) The following image parodies the Margaret van Wyk incident in which the town of Schweizer-Reneke made the local news after a particular message was sent on WhatsApp. Discuss the incident by drawing on what was covered in legal lectures concerning privacy and freedom of expression. In addition, identify the three parties that could stand to face legal liabilities for their actions. For each party, briefly discuss what legal implications they face, motivating each implication identified.
