QUESTION 1 [30 MIN: 30 MARKS]

The establishment of the relief support network and its enablers require systematic placement of communication, automation, personnel and facilities to achieve the proper end state. Discuss the Distribution Network Enablers required to provide the proper intransit visibility necessary to monitor the flow of commodities and equipment through the network.
