INSTRUCTIONS

Answer the following essay question. Make sure that your essay is well structured (include an overview of the issue and state your overall argument in the introduction, three points that support your introduction, and a conclusion) and refers to the readings covered in the course. You can provide examples to support your argument if you wish. There is no correct answer; what matters is that your answer is well-presented and argued and that its parts are consistent.

You should spend 10 minutes outlining your essay plans and about one and a half hours writing your essay. Your essay should be 6-7 pages.

SECTION B: ESSAY

How does power promote or constrain development, defined as “good change” that also promotes structural transformation. Reflect on how power is asserted by different actors and at different levels in the following areas:

a) Global and national actors: the promotion and practice of democracy and good governance. (prompt: Do they create a positive framework or impose Western ideas that inhibit development?)

b) Civil society: loyalty, participation and protest. (prompt: Is it possible to find a way to initiate change or are we stuck in a historical period with certain political system?)

c) National and local state: invisibility and corruption (prompt: Is it possible to overcome these factors or are they set to undermine good efforts being made?)
