Durban July is a Vodacom horse racing event that happens every first week of July in Kwa-Zulu Natal, South Africa. During this weekend a large number of people travel down to Durban to enjoy the festivities during.

Mango airline is a state owned South African low cost airline.

Mango airlines has experienced an upsurge in the number of people that want to use the airline as a result of the Durban July event and in light of news that their competitor Comair, operates 8 Boeing 737 Max 8 aircrafts. The Boeings 737 Max 8 are believed to have technical issues which resulted in two major air crashes in the past 5 months. As a result, customers do not want to fly Comair.

While Mango has 17 aircrafts in total, usually only 2 aircrafts are allocated for the Durban trips on a daily from Johannesburg, one at OR International Airport and the other at Lanseria Airport. Each aircraft completes 4 trips. There are in total 11 trips into Durban and 11 trips out of Durban International airport on a daily, including flights from other parts of the country such as Cape Town, Port Elizabeth, etc. These aircrafts hold a maximum of 186 passengers on board.

Usually by end of March, only 25% of the different leg trips would be booked. However, this year, the flights were already booked to 60% of their capacity as at 14 March 2019. On that weekend, the majority of the people fly out of Johannesburg on Friday afternoon and return on Sunday midday to early afternoon.

Mango buys fuels in bulk and stores it in a rented storage facility, as the fuel has to be stored in a specific way. They usually hold high storage of fuel during peak travelling times such as school holidays and major events like the Durban July. This facility costs them R50000 a month to store 10000 liters of fuel.

Question 1:

Greenspace Communication Services is a leading business solutions provider that was founded by two friends who studied at university together ten (10) years ago. Greenspace’s webpage explains its business approach as follows:

*“While many changes have occurred in the industry over the past decade, our belief in the need for the best customised communication system and high level of commitment has remained. Greenspace’s highly trained staff ensure customers always receive excellent reliability and technology. Should a problem arise, their own technicians are available 24 hours a day, 7 days a week”.*

Greenspace employs 200 technicians who each have detailed specialist knowledge of different systems and a sales team which stays up to date on the different solutions available. Greenspace’s call centre staff forward most queries from existing customers to the relevant technician and enquiries from potential new business clients to the sales team.

The Executive Committee of Greenspace meets monthly to review company strategy and performance and at the last meeting they noted that;

- Staffing costs as a proportion of sales are higher than its competitors;
- Several competitors are now offshoring some of their activities;
- Greenspace’s technicians are highly skilled and knowledgeable but in only a few systems.

The CEO drew reference to the training budget and has asked if economies could be made.

For their next scheduled meeting the Chief Operations Officer has agreed to investigate the potential for offshoring part of Greenspace’s operations

Question 2

20 marks

Bradlows is a manufacturer of bedroom furniture with four factories in the south of the country. As a result of declining company financial performance, the Managing Director (MD) engaged a

management consultant to conduct an overall review of Bradlow's activities and highlight the issues of greatest concern.

The management consultant's main findings are as follows:

- No systematic Quality Control exists and differing operating efficiencies exist both within and between Bradlow's factories;
- There is an increasing incidence of furniture being returned which requires replacement or reworking. There are also a substantial number of items returned as part of extended guarantee arrangements;
- Currently Bradlows tries to sell its full product range to all potential customers, even though it is geographically difficult to fulfil obligations to customers in the north of the country. Bradlows needs to rethink this marketing approach and should undertake careful market segmentation.

Having considered the consultant's report, the MD has decided that Bradlows will conduct a detailed exercise in market segmentation and, furthermore, will put in place measures to improve product quality. The Production Manager has, however, previously suggested to him that the way forward is to employ dedicated Quality Control (QC) inspectors as part of a Quality Control (QC) system. The MD has also launched a new initiative he calls 'sharpening the focus' which is centered on improving corporate governance, connecting more closely with customers and improving marketing practices.
