The short answer to the question 'how free is the South African media?' the simplistic answer would be 'quite free'. After all, media freedom is constitutionally protected and South Africa has arguably the freest media in Africa. However there are signs that as the honeymoon phase of our new democracy fades, so it becomes clear that attacks on media freedom are increasing. Over the past few years, the FXI (Freedom of Expression Institute) has charted a trend of increasing censorship of the media and individual journalists. This censorship is not only directly applied through laws and lawsuits, but also indirectly, through withdrawal of advertising and self-censorship. While the big media organisations are usually well equipped to deal with these dangers, small community newspapers often lack the knowledge, skills and resources to fend off these threats to their freedom to publish, or their very existence.
