PART A: THE MINE HEALTH AND SAFETY ACT, 1996 (ACT 29 OF 1996) AS AMENDED

Tau Copper Mine in the North West Province has been forced to consider closure of its operations due increased cost and the drop in the price of copper. The owners of the mine are pleading poverty and do not want to abandon the mine as yet because they are hoping to get investment from outside investors in the near future. In order to keep the mine going substandard mining is carried out with an increased risk to employees and people residing within close proximity to the mine.

- i) What are the rights of employees employed at Tau Copper Mine in terms of the Act for doing work in working places which risky and not healthy? (3)
- ii) What are the requirements of the Act in terms of the employer maintaining a healthy and safe working environment at this mine? (1)
- iii) What does the Act prescribe in terms of people who are not employees, but who may be directly affected by activities at Tau Copper Mine? (4)
- iv) What powers does the Inspector have for the purposes of monitoring or enforcing compliance? (3)
- v) What further powers does the Inspector have whilst still at the mine? (10)
- vi) The Inspector concludes that Tau Copper Mine has failed to comply with provisions of the Act, what powers does the Inspector further have? (3)

The unsafe working conditions at Tau Copper Mine have resulted in fatal injures of two employees.

- i) What powers does the Chief Inspector of Mines have in terms of the Act if he/sheFeels that further assistance is needed? (1)

B: MINE SURVEYING REGULATIONS

The area where West Wits Gold Mine has obtained a mining lease is known to be unstable due to sinkholes and subsidence that have been observed on a stretch of ground between three inclined shafts developed on reef. The reef dips uniformly at an angle of 30° in the easterly direction and sinkholes and subsidence are 121 meters measured horizontally in the direction of true dip from the outcrop position. Due to the Railway line which is 90 meters from the outcrop in the easterly direction; the reef from the outcrop, to 250 meters measured horizontally could not be mined. The occurrence of subsidence has forced the South African Railway to close this line for safety reasons.

The shafts are 150 meters apart. The ground available for mining stretches from 120 meters south of the first inclined shaft to 160 meters north of the third inclined shaft. It is also known that the old mine which lied 205 meters from the reef outcrop has been flooded with a possible accumulation of dangerous gas and therefore the new mine cannot use the old infrastructure. The cause of flooding to the old mine is as result dolomitic rock formations in the area. The owner wants to construct a hoist room, the metallurgical plant and built working offices as close as possible to the outcrop position, in the western side of the outcrop. A maximum overburden of ten meters will be allowed and the rest of the reef will be mine by underground means. Average thickness the reef is eight meters.

- b) The employer is required to take measures to insure health and safety and any condition that might pose a significant risk to persons employed by the new mine.
