### **QUESTION 2**

You are a journalist working for a daily newspaper in Gauteng, and have been sent to the Gauteng High Court to cover the most recent developments in the Kamogelo Mabu murder trial. Write a short (no more than 250 words) story based on the following notes you took during today's trial.

Case is before Judge Thuli Ndlovu

- Moses Mpondu (29) is charged with the murder of businessman Kamogelo Mabu (54)
- Mpondu is charged with
- Gunning down Mabu
- In Randburg, on the intersection between Republic and William Nicol road
- Mabu had come to a stop before a red light
- And Mpondu, while on a motorcycle, drove past Mabu's BMW 2 series convertible
- And fired several shots into the car, 5 of which hit Mabu, killing him instantly
- This all happened on Friday 19 April 2018, at 20:00
- Today Mpondu's lawyer, Albert Qwabe, introduced a new piece of evidence
- Which claims that Mpondu was acting on behalf of Mark Sithole
- Sithole was a business colleague of Mabu
- And according to Qwabe, Sithole orchestrated the hit in order the gain the controlling share in their jointly owned company SitU Communications
- If information is credible Mpondu could receive a reduced sentence
- The trial is currently in its 2<sup>nd</sup> week

Idai brought strong winds and caused severe flooding in Madagascar, Mozambique, Malawi, and Zimbabwe, which killed at least 1,303 people — and affected more than 3 million others. Catastrophic damage occurred in and around Beira in central Mozambique. The President of Mozambique stated that more than 1,000 people may have died in the storm. A major humanitarian crisis unfolded in the wake of the cyclone, with hundreds of thousands of people in urgent need of assistance across Mozambique and Zimbabwe.
