Write an essay in which you critically assess the study from a methodological point of view, paying particular attention to the appropriateness of the study design, data collection methods, sampling strategies, analysis methods and conclusions drawn. You should also comment on the ethical approach of the study and questions of rigour.

The following questions can guide your essay. DO NOT answer question by question. These are posed for your guidance. Rather you should craft an ESSAY in which you ensure you cover all of the questions.

1. Was the research design selected appropriate to the question being asked?
2. Were the data collection methods appropriately selected and applied?
3. Was the sampling method appropriate?
4. Was the analysis method used appropriate for the purpose of the study?
5. Was the study conducted ethically?
6. Are the conclusions appropriate to the methods selected?
7. What is your assessment of the rigour of the study?
8. What is your overall assessment of the study (strengths/weaknesses)

Ensure that you demonstrate your reasoning and substantiate your standpoint by referring to appropriate prescribed and recommended readings.

Your essay should be no longer than 4000 words (4-5 pages).
