INTERNATIONAL COMMERCIAL LAW A

You are invited to consider the following scenario and answer the questions that follow.

Consol SA (Pty) Ltd (Consol) is a company incorporated, domiciled and resident in South Africa; its central administration and principal place of business are in Johannesburg (South Africa). Consol does not have branch offices anywhere else in the world but is the owner of assets in British Columbia (Canada), India and South Africa.

Glass-Smith & Co Canada (Glass-Smith) is a company incorporated, domiciled and resident in British Columbia (Canada); its central administration and principal place of business are in British Columbia. Glass-Smith has no branch offices anywhere else in the world, nor does it own any property abroad.

Consol (seller) and Glass-Smith (buyer) concluded a contract of purchase and sale in respect of five (5) tons of unrefined glass. (South Africa is one of the most prominent exporters of glass in the world.) The contract was concluded in Abuja (Nigeria) during February 2020.

In terms of the contract, the glass had to be delivered by Consol to a warehouse at Oliver Tambo airport, Johannesburg, South Africa (ORT) during March 2020, to be transported to Barcelona (Spain) by Iberia Airlines for further distribution in various European countries. Payment by Glass-Smith had to be effected in Consol's account at Central Bank of India in Mumbai (India) by way of documentary letter of credit.

The parties expressly chose the law of British Columbia (Canada) to govern their contract. However, they neither expressly nor tacitly selected the courts of a particular legal system to exercise jurisdiction over matters that may arise as a result of a dispute between them.

Glass-Smith indeed effected payment and delivery also took place but it (Glass-Smith) claims that the quality of the glass as delivered by Consol was dissimilar to that which was actually agreed upon.

Both the Brussels Ibis Regulation and the Hague Convention on Choice of Court agreements apply in Spain.
