Thuli is a celebrity who has built a successful career as a fashion model, television presenter, magazine editor and businesswoman. In December 2012, Thuli purchased a bicycle and related cycling equipment from Cycle Pro (Pty) Ltd. She continued browsing in the shop and, while trying on a cycling helmet in the shop, an unknown man took a photograph of her. She made a few more purchases and then left the shop.

A few weeks later Thuli is angered and embarrassed to learn that Cycle Pro (Pty) Ltd has published the photograph of her trying on a cycling helmet in an advertisement for the shop. It appears in a sales brochure titled "Hot Sales for Hot Cyclists". Her anger stems from the fact that Cycle Pro (Pty) Ltd has exploited her image for commercial purposes

without her knowledge and consent. Cycle Pro (Pty) Ltd has published a low-quality photograph of her in a poorly designed advertisement for its shop. Thuli is embarrassed, as she fears that her friends, colleagues and peers will assume that she consented to the publication of the photograph, thereby lowering her professional standards and standing. Thuli wishes to sue Cycle Pro for *iniuria* on the basis that its conduct amounts to an invasion of her privacy, alternatively, that it infringed her right to dignity.

Advise Thuli on the following:

Whether Cycle Pro (Pty) Ltd invaded her right to privacy, alternatively infringed her right to dignity. [20 marks]
