Write short paragraphs (±10 lines) on *three* of the following.

- 1. Provide a brief description of the importance of philosophy of science to the humanities.
- 2. In your own words, explain what you understand by the term "middle range theory" when used in connection with trying to account for change in the past.
- 3. What are some of the weaknesses associated with scientific empiricism, as identified by the post-processual school of thought?
- 4. With reference to studies of symbolism and technology in the Middle Stone Age, describe the main focus of cognitive processualism.

### Question 2: (35 Marks)

Answer the following <u>compulsory question</u>. You should use ethnographic examples from the course readings in your answer.

1. If Amadiume has provided scathing critiques of the old 'masters' theories in anthropology. Critically unpack at least three of these theories, their contributions to the canon as well as their critiques.
