- 1.5.1. Explain briefly who may consent to the use of a body or tissue. (2)
- 1.5.2. For what main purposes may a body, or tissue from a body, be used? Name these purposes. (2)

### **QUESTION TWO**

Mrs. Xavier was pregnant with twins and goes into labour prematurely. One of the twins dies shortly after childbirth. The twin that died was still connected via the umbilical cord to her mother and the twin moved for a short time before dying. The second twin that was born screamed loudly when she was born. After cutting the umbilical cord of the second twin, she was placed in an incubator. The second twin survived. With reference to the set of facts, mention what the requirements are for birth for the purposes of the granting of legal subjectivity. Also explain whether the twins would have been deemed to be legal subjects and whether their births needed to be registered, give reasons for your answer. (10)

# **QUESTION THREE**

Mr. Dlamini married Miss Zinta. The wedding ceremony was held in Johannesburg at a beautiful lakeside venue. Mr. Dlamini lives and works in England and flew to South Africa for the wedding. Miss Zinta, after the wedding known as Mrs. Zinta-Dlamini, lived and worked in Pretoria prior to the wedding. Before their wedding Mr. Dlamini heard "voices" in his head telling him that he must wear purple shoes and socks on the day of the wedding and that after the wedding ceremony he must do ten cartwheels on the lawn in front of the wedding guests. Mr. Dlamini then complied with what the voices told him and wore the purple shoes and socks and did ten cartwheels on the day of the wedding. Mr. Dlamini has never been admitted to a

health care establishment for treatment for mental illness but has been seeing a psychiatrist as an outpatient for two years. Mr. Dlaminis's friends describe him as outgoing and eccentric. Prior to the wedding the parties did not sign an antenuptial contract. Answer the following questions briefly:

3.1. The matrimonial property system of which country will be applicable to their marriage? In your answer pay particular attention to the domicile of the parties. (3)

3.2. Explain briefly what the test is for mental illness as defined by the South African courts.
