#### Question 2

Tshepang and Iris had just got married and were flying in an airplane on their way to Mauritius. On the way, the airplane crashed into the sea. The remains of the aircraft are recovered as well as the bodies of Tshepang and Iris. For the purposes of succession, their heirs want to know whether Tshepang or Iris died first. Briefly explain the legal position, fully summarise case law in your answer. [15]

### Question 3

Mandla is marrying Sam. Before the wedding Mandla hears 'voices' in his head telling him that he must wear purple dotted socks and shoes to the wedding and to do ten cartwheels after the ceremony. Mandla complied with the voices. He has never been admitted to a health establishment for the treatment of mental illness but has been seeing a psychiatrist for the past two years. Prior to the wedding the parties did not sign an antenuptial contract.

- 3.1 What is the test for mental illness as defined by the South African courts? Explain briefly.(2)
- 3.2 What is the onus of proof in cases relating to mental illness and who bears the burden of proof? Refer to case law and legislation and the set of fact, where applicable, and explain your answer.(8)

### Question 4

Lebo is a 16-year-old student. She entered into an instalment sale agreement with Sam (aged 21) for the purchase of the latest iPhone for R15 000. Her parents approved of the contract when she showed them the iPhone. The real market value of the iPhone was R10 000. Lebo paid the first instalment of R1 000 and the deposit of R1 000 but one month after delivery the iPhone was stolen. Lebo now refuses to pay any further instalments to Sam. Referring to this set of facts, answer the following questions:

- 4.1 Is there a legal remedy that Lebo can use in these instances? Name this remedy and list the requirements that Lebo must satisfy to use this remedy. (3)
- 4.2 Have the requirements in your previous answer been met? If so, indicate by referring to the set of facts how they have been met. (3)
- 4.3 Could this remedy, mentioned in your answer in 4.1. above, be used if the minor acted fraudulently? Motivate your answer. (2)
